

OFFICIAL RULES
Little Big Town at The Wiltern Ticket Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Open only to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec) 18 years of age or older. Void where prohibited.
